The 2024 Mid-Atlantic Convention promises to be another exceptional grower gathering. We will be joined by the North American Strawberry Growers Association!

An estimated 2,200 or more persons are expected for the 2024 edition of the Mid-Atlantic Convention January 30 to February 1 at the Hershey Lodge in Hershey, Pennsylvania. Over 160 companies will represented in the trade show which is sold-out with a waiting list of exhibitors anxious to get into the show. A series of pre-convention workshops and a farm market bus tour on January 29 are expected to attract several hundred participants with the bus tour usually being sold out. This year's Convention is noteworthy because the members of the North American Strawberry Growers Association from all over the continent will be holding their annual meeting in conjunction with the Mid-Atlantic Convention. Various committees have been planning for the 2024 Convention with the goal of building on the 47-year history of a premier grower educational event.

## December AppleTracker Storage Report

The total number of apples in storage on December 1, 2023, was 173 million bushels, 29 percent more than last December's total of 134 million bushels and 19 percent more than the 5-year average for that date.

Fresh apple holdings this December totaled 124 million bushels, 33 percent more than the inventories reported for last December. Processing holdings totaled 49 million bushels, 19 percent more than last year on December 1.

This report captures more than 95 percent of the national storage capacity.

## USAppleTracker: Harvest Wrap-Up Webinar

Chris Gerlach, USApple's Economist and Director of Industry Analytics, will review the latest storage reports, helping the industry recalibrate for the remainder of the marketing year. The webinar will highlight findings from the proprietary USAppleTracker national storage surveys that detail the holdings and movement of U.S. apples by state, variety, use and storage type over the course of the year. These data are critical to understanding where we are relative to prior seasons and for identifying prevailing trends in production and varietal shifts.



## News from the Specialty Crop Farm Bill Alliance

What is the Farm Bill?





## AMERICAN AGRICULTURE. STRONGER TOGETHER.

Congress has enacted legislation that extends the 2018 farm bill for an additional fiscal year. It is a clean extension that fully funds our farm bill programs through September 30, 2024, without any additional enhancements or changes.

What does this full year extension mean for the future of the farm bill?

The bipartisan leadership of the House and Senate agriculture committees released a joint statement on November 12<sup>th</sup> that this extension is in no way a substitute for passing a five-year farm bill and that they are committed to working together to accomplish that goal next year. We anticipate there will be significant activity on the farm bill in both chambers throughout 2024, particularly during the first quarter of the year, as House and Senate leaders attempt to conclude their work before the 2024 election season is fully underway.

What has the SCFBA been doing to prepare for 2024?

At the beginning of this year, the SCFBA published more than 100 farm bill recommendations to enhance the competitiveness of specialty crop growers in the United States. We published two additional proposals this summer that would make effective and affordable crop insurance available to all specialty crop growers. The SCFBA Legislative Committee, co-chaired by Diane Kurrle (U.S. Apple) and Rebeckah Adcock (IFPA), has facilitated countless meetings with the members and staff of the House and Senate agriculture committees and recently hosted two well-attended policy briefings open to all House and Senate staff working on the farm bill. More than a dozen marker bills advancing Alliance priorities have been introduced in the House and in the Senate and more are in the works.

On a personal note, we have not had a single interaction in which we've been told that we don't need the things we as an industry are requesting in this farm bill. What we are told, however, is that resources are limited, and we might not get everything we want. Specialty Crops account for nearly half the farm gate value in the United States and receive far less than ten percent of the farm bill's resources. It is imperative that we continue fighting for additional resources to advance ALL our priorities throughout the entirety of this process.

As we conclude 2023 and prepare for 2024, we are confident that the SCFBA is advancing the right suite of proposals to help our growers stay competitive in an increasingly difficult environment. We remain vigilant and look forward to engaging with you more frequently as the pace of legislative activity increases throughout 2024.


