The reserve fund is currently at maximum capacity, thus 10% of the collections cannot be put

towards the reserve. The balance will be distributed equally between U.S. Apple Association,

Virginia State Horticultural Society and Virginia Agricultural Research Program.

VI. **Board member terms/nominations**

Board Members, Heather Mckay, Shannon Showalter, and Bethany Schaelpler terms will

expire on June 30, 2025. Ms. Schaepler in District Three stated she would like to serve

another term. Ms. McKay wishes to step down and Mr. Showalter may step down if a

replacement is secured. Board members for the positions in District One and District Two

will be solicited by the program manager and other board members.

VII. Flair Communication – Website and Social Media Accounts

Ms. Girvan with Flair Communication was not present but provided a written proposal for

the website and social media campaign. The analytics for the website and social media

campaigns were also shared. Ms. Girvan suggested possibly adding an additional \$300 to

social media ad campaign for the 2025 proposal.

A motion was made and unanimously approved to accept the proposal for the 2025 year to

include the additional \$300 for social media ad campaign if these funds came from re-

distributing of the service fees and the proposal amount did not exceed the presented total

annual cost of \$9,994.

A second motion was made and unanimously approved to accept the proposal as originally

proposed in the event that the first motion's request was unable to be implemented.

VIII. VSHS Update and Apple Tax Assessment Discussion

Laura Wiley, Executive Secretary and Greta Liskey, President of the Virginia State
Horticulture Society (VSHS) gave an update regarding society membership, apple tax
assessment concerns among VSHS Board Members, and the future direction of VSHS.
Membership has dwindled and the society is trying to determine their relevancy to the fruit
and vegetable growers. The discussion focused on industry trends of fewer processing apple
growers, who historically have contributed the most through apple tax revenue. Ms. Wiley
reported revenue generated from the apple tax was reduced by 20% for the 2023 crop and
projections would be nearly the same reduction for the 2024 crop. For 2025, the VSHS plans
to explore options regarding possibly modifying the Virginia Apple Tax code through
legislation and assistance with Virginia Farm Bureau.
